

St. Paul Bird Fair Vendor Contract

I appreciate your cooperation in abiding by the following rules for the St. Paul bird fair. If the fair coordinator (Emily Roberts) finds any vendor in violation of these rules, the vendor will be required to immediately leave the fair and will relinquish all table rental fees.

1. Only pet products or live birds may be sold or present at the fair.
2. Vendors will bring only healthy birds to fairs; any birds that are or appear sickly will be removed from fair activities immediately. Vendors will be held liable if one of their birds is found to have spread an illness to another bird, and will therefore be responsible for funding any required vet bills of the affected bird as presented by its owner. This liability also applies if one of the vendor's birds injures (i.e. bites) another bird or human.
3. Vendors will be responsible for covering their table(s) with a tablecloth.
4. Only vendors with a rented table will be allowed to sell products or services.
5. Table locations may only be changed after approval from the fair coordinator.
6. Vendors may not attach anything to the walls.
7. Smoking, alcoholic beverages, firearms and other weapons are NOT allowed in the building.
8. The fair coordinator is not responsible for business transactions between buyers and sellers, such as bad checks, misrepresentation, taxes, etc.
9. Under no circumstances shall the fair coordinator be held liable for damage, injury, illness or theft to any person or property, including birds. Vendors are responsible for their own birds' health & behavior, as well as obtaining their own liability insurance in the case of an injury caused on their behalf.
10. Vendors may start setting up their tables at 10:00am on the fair date, and must be ready by 12:00pm, by which time the fair is open to the public.
11. The fair coordinator has the right to ask a vendor to leave (and relinquish all table rental fees) if substantial conflicts arise.

Payments must be received prior to the fair date in order to reserve your table space(s) for that fair at the price of \$30 per table (before discounts). On the day of the fair, tables will be \$35.00 each with no discounts given on multiple spaces/tables. However, tables paid for one-fair ahead of time will be discounted to \$25 each.
